

DJ Levi Entertainment Contract and Terms Agreement

This Contract for Services is made effective as of

by and between _____ and DJ Levi Entertainment of Smyrna, Tennessee, 37167.

NOW, THEREFORE, FOR AND IN CONSIDERATION of the mutual promises and agreements contained herein, Service Recipient hires Service Provider, Service Provider agrees to provide Disc Jockey service to the Service recipient under the terms and conditions hereby agreed upon by the parties:

DESCRIPTION OF SERVICES. The Service Recipient hereby agrees to engage the Service Provider to provide the Service recipient with DJ services (collectively, the “Services”) to be performed at the following event(s):

PERFORMANCES OF SERVICES. a. DJ shall arrive one hour before the starting time to set-up and conduct a sound check. DJs play list shall have editions of songs from both the latest and old classics. DJ shall incorporate guest requests into the play list unless otherwise directed by the Service Recipient. Music shall be played without any breaks and should continue during dinner and dancing. DJ shall also have quality microphone, sound system, and provide quality sound mixing.

PAYMENT. Service Recipient agrees to pay Service Provider in consideration of the services contracted for the sum of _____, to be paid upon arrival before services are rendered at the date specified. Event has a (4) hour block, which is required. If you desire a lesser or greater time period, you will have to purchase our premium packages. This contract is still applicable to all packages.

TERM. The Service Recipient and the Service Provider agree that this Contract between the parties for DJ service shall commence on the above on the referenced date and complete after services are rendered. Said agreement may be extended and or renewed by agreement of all parties in writing thereafter.

WARRANTY. DJ Levi (Krinson Robinson) shall provide its services and meet its obligations under this Contract in a timely and workmanlike manner, using knowledge and recommendations for performing the service which meet generally acceptable standards in the DJ Levi Entertainment Community.

FORCE MAJEURE. If performance of this Contract or any obligation under this Contract is prevented, restricted, or interfered with or by causes beyond either party's reasonable control ("Force Majeure"), and if the party is unable to carry out its obligations gives the other party prompt notification to the extent necessary by such event, then the obligations of the party invoking this provision shall be suspended to the extent necessary by such event. The term Force Majeure shall include, without limitation, acts of God, fire, explosion, vandalism, or other similar occurrence, orders or acts of civil authority or by national emergencies, insurrections, riots, or wars or strikes, lockouts and so on and so forth.

AMENDMENT. This Contract may be modified or amended in writing, if the writing is signed by the party obligated under the amendment.

CANCELLATION TERMS. In the event you have to cancel without the clause, “FORCE MAJEURE,” a service fee (50% of final balance) will be required to be paid at the time of cancellation, for application and contract fees. The time period is requested at least 48 hours prior to the scheduled event.

GOVERNING LAW. This contract shall be constructed in accordance with the laws of the State of Tennessee.

ENTIRE AGREEMENT. This contract contains the entire agreement of the parties, and no other promises or conditions in any other agreement whether oral or written concerning the subject matter of this Contract is invalid or unenforceable, but that by limiting such provision it would become invalid and enforceable, then such provision will be deemed to be written, construed, and enforced as so limited.

WAIVER OF CONTRACTUAL RIGHT. The failure of either party to enforce any provision of this Contract shall not be construed as a waiver or limitation of that party’s right to subsequently enforce and compel strict compliance with every provision of this Contract.
